

Loudoun General District Court: Planning your trip to the Courthouse

The Loudoun General District Court is operational at the new location of 2 Church St. NE, Leesburg, VA 20176 effective October 31, 2023. Mail addressed to the Loudoun County General District Court will be forwarded to the new location from the previous location of 18 E. Market St., Leesburg, VA 20176, for a period of 12 months from October 31, 2023.

Upon your arrival, please follow wayfinding signage directing you to the courts located in each building of the judicial complex. The General District Court clerk's office as well as General District Court courtrooms are located at 2 Church St. NE. The Loudoun County Circuit Court and Loudoun County Juvenile and Domestic Relations Court remain at the 18 E. Market St. location.

Those visiting the courthouse can continue to use the free parking located at the Pennington Garage and Parking lot located at 210 Church St. NE, Leesburg, 20176 and the Semones Parking lot with additional accessible parking.

The courtesy courthouse shuttle service for employees and members of the public is operated by Loudoun County Transit. The shuttle service is operation Monday to Friday 7:15 am to 5:30 pm. The shuttle stop at the courthouse complex is directly in front of the new courthouse at 2 Church St. NE. 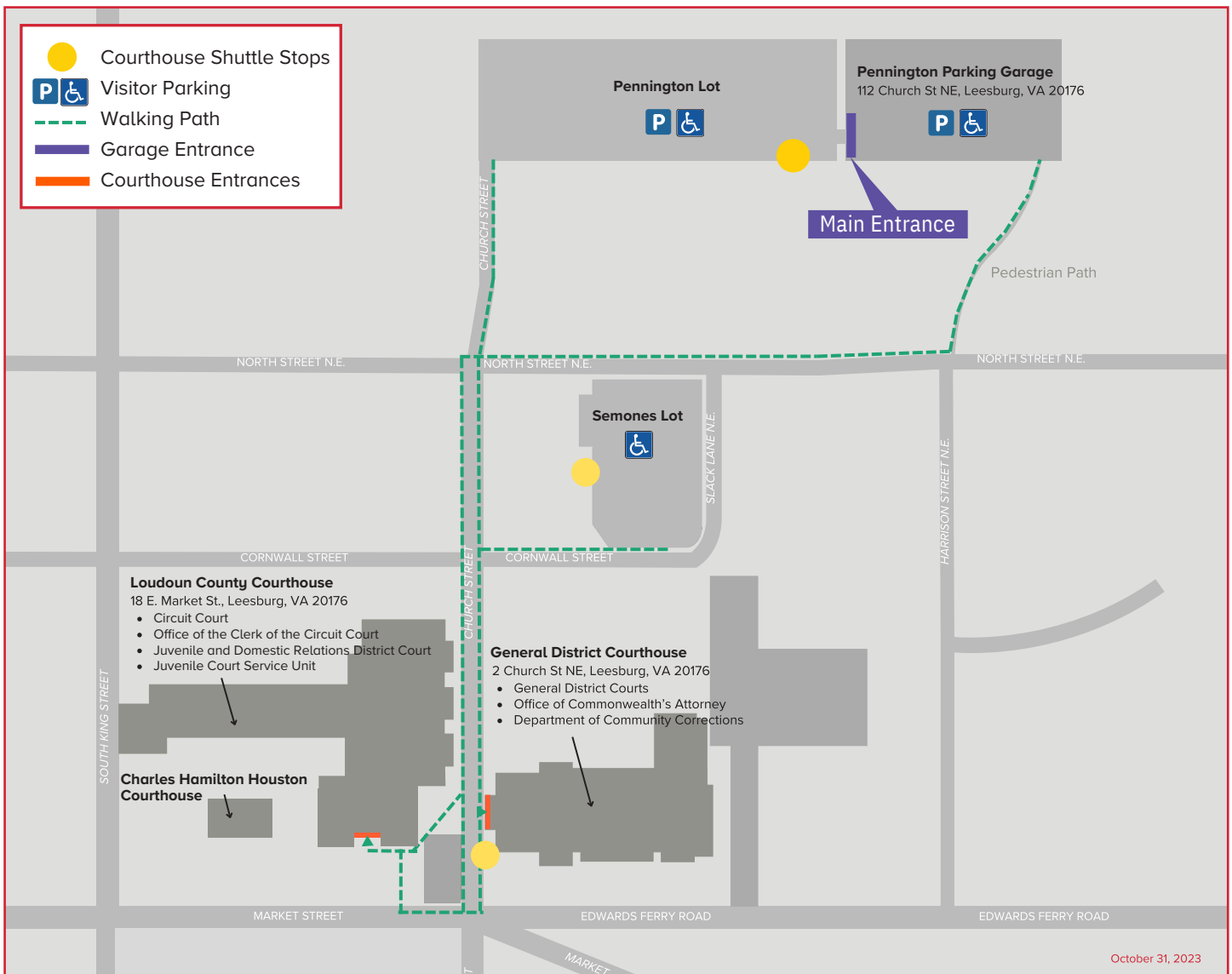

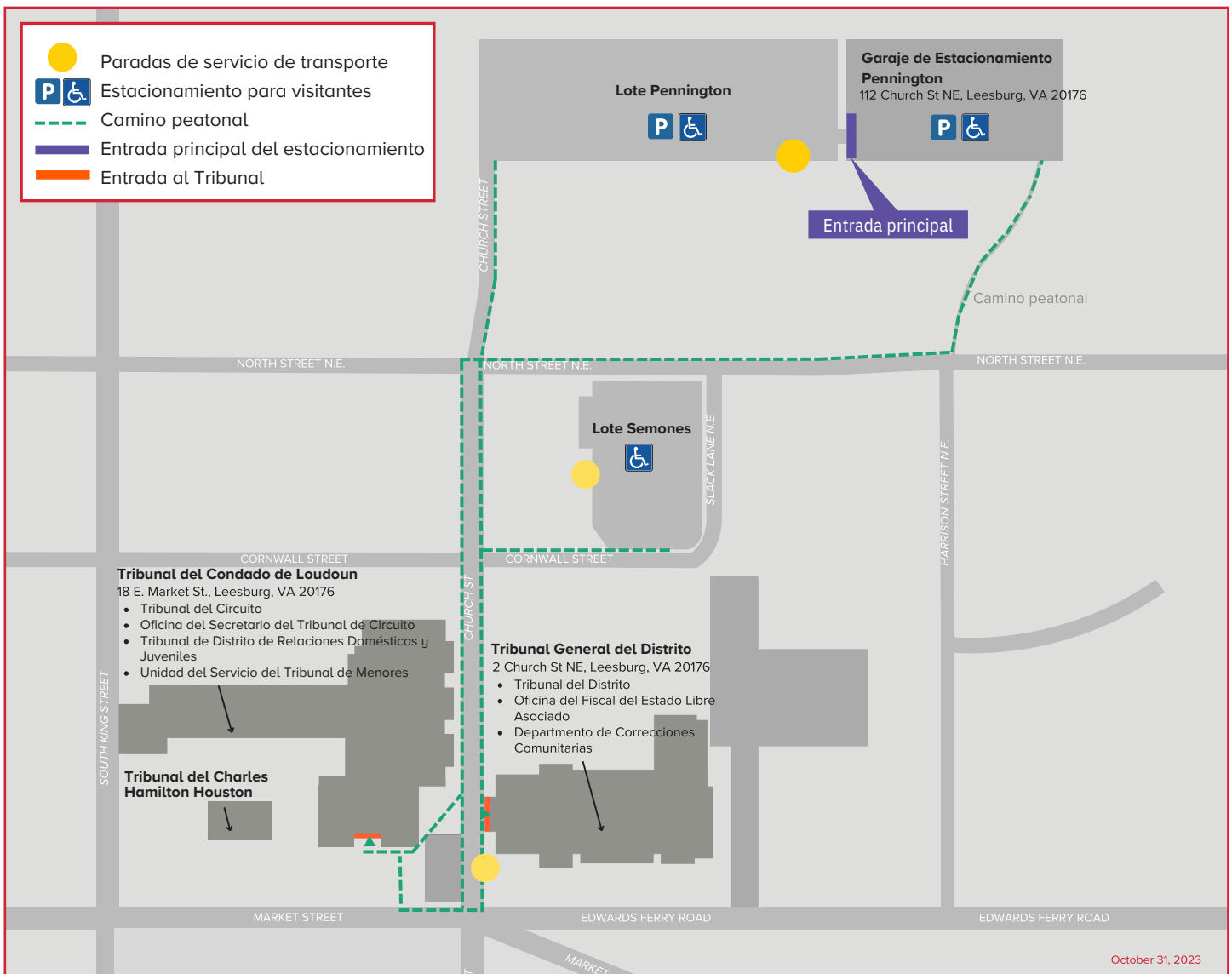
