### H. Notes for Courts Who Scan Documents

1. Some clerk's offices require the recording agent to provide a copy of the document being recorded, or to pay an additional \$0.50 per page for copying the document if immediate return of the recorded document is requested.
2. The recording process comprises scanning, indexing and verification of the record. A digital image is a non-permanent record. Clerks are required to verify the record created in the office from the original document or an exact paper copy until the verification process is complete.
3. [Virginia Code § 17.1-275 \(A\)\(8\)](#) provides for a fee of \$0.50 for each page or, if an electronic record, each image.

### 2. Amount Consideration & Value Column

- a. **Consideration** (CON) is the reported payment or recompense for the transfer.
- b. **Actual Value** (VAL) is synonymous with the term **fair market value**, the price at which the property would change hands between a willing buyer and a willing seller, neither being under any compulsion to buy or to sell and both having reasonable knowledge of relevant facts. Actual value may be determined by viewing the following evidence:
  - Certified appraisal of the value of the property being conveyed.
  - HUD-1 or other Settlement Statement providing the purchase price of the property being conveyed.
  - Comparing the reported consideration with the locality's most current assessment.
  - Using the most current Virginia Department of Taxation Assessment Sales Ratio report -- If the median ratio is less than 100% (and that appears to be the case in almost every locality on the Report), this indicates that the assessment for the property type is less than fair market value. In almost every locality, this method will not help the clerk establish a lower actual value than the local assessed value. If the clerk uses this method, the fair market value of the property is calculated by taking the assessed value of the property and increasing it by the resulting percentage for the property group as described above in the example.

- **HB574 – Effective July 1, 2024** – Provides in § 58.1-801, that for purposes of recordation taxes, the value of a property interest conveyed shall be the most recent property tax assessment for such property at the time the property is conveyed.
- The FAS will **calculate on the higher of the two values** when both consideration and actual value are entered on the FAS receipt screen.
- [§ 3-6.01](#) **Deed Processing Fee** (036) charged when there is a state grantee tax (039) assessed under [§§ 58.1-802](#) and [58.1-803](#).
- [§ 58.1-802](#) **State grantor tax** (038), when the consideration or value of interest, whichever is greater exceeds \$100, is based on \$0.25 per \$500 or fraction thereof on the greater of deed consideration or property value. **Local grantor tax** (220) based on \$0.25 per \$500 or fraction thereof.  
**Note:** Only jurisdictions of primary or first recording (JUR=Y) collect state taxes. Jurisdictions of secondary recording (JUR=N) only collect local recordation taxes.
- [§ 58.1-803\(D\)](#) **State grantee tax** (039) for all instruments **except RFDT** is \$0.25 per \$100 value or portion thereof on first \$10 million, \$0.22 per \$100 on next \$10 million, \$0.19 per \$100 on next \$10 million, \$0.16 per \$100 on next \$10 million, and \$0.13 per \$100 value over \$40 million in value. **Local grantee tax** (213) is 1/3 of state amount.  
**Note:** Only jurisdictions of primary or first recording (JUR=Y) collect state taxes. Jurisdictions of secondary recording (JUR=N) only collect local recordation taxes.
- [§ 58.1-803\(E\)](#) **State grantee tax** (039) for the **RFDT instrument** is \$0.18 per \$100 value or portion thereof on first \$10 million, \$0.16 per \$100 on next \$10 million, \$0.14 per \$100 on next \$10 million, \$0.12 per \$100 on next \$10 million, and \$0.10 per \$100 value over \$40 million in value. **Local grantee tax** (213) is 1/3 of state amount.  
**Note:** Only jurisdictions of primary or first recording (JUR=Y) collect state taxes. Jurisdictions of secondary recording (JUR=N) only collect local recordation taxes.

3. Total Cost & Tax Column

**Effective July 1, 2017**, allows courts with a network or system for electronic filing of land records to charge a 423 E-Recording fee **not to exceed** \$5 per instrument for every land record filed by paper pursuant to [§ 17.1-258.3:1](#).

- For **credit/debit card payments**, a credit/debit card convenience fee (account code 407) is charged and may vary from court to court pursuant to [§ 17.1-275\(A\)\(27\)](#).
- **Effective July 1, 2017**, pursuant to HB1500, item 365c, the [§ 58.1-817](#) Virginia Outdoor Foundation (VOF) fee (account code 035 @ \$1.00) is charged on every deed admitted to record in those jurisdictions in which the Virginia Outdoor Foundation holds open-space easements. The following instruments are exempt from the VOF fee: CSH, HWM, LPZ, OEV, ONC, OCC, OCCR, RLIEN. **Effective July 1, 2020** pursuant to [HB1623](#), [§ 58.1-817](#) Virginia Outdoor Foundation (VOF) fee (account code 035) increased to \$3.00.
- **Effective May 1, 2021**, some courts impose a Regional **WMATA** Capital Fee pursuant to [§ 58.1-802.3](#). The rate of this fee, when the consideration or value of the interest, whichever is greater, equals or exceeds \$100, is \$0.10 for each \$100 or fraction thereof. The fee is imposed on the grantor and is based on the date of recording in the clerk's office. Instruments having an asterisk (\*) in the RWCF 015 table column are eligible for the fee: DAOC, DB, DBL, DBS, DBSLE, DCOR, DEX, DDRT, DIT, DLF, DOA, DQC, DSC, DTAX, DTD, DTF, DVL.
- Recordings in a multiple jurisdiction court, like Prince William County/Manassas Park City/Manassas City use the below local recordation fees:
  - County (LOC = CO): grantor = 220, grantee = 213, transfer = 212
  - City #1 (LOC = CI): grantor = 223, grantee = 214, transfer = 222
  - City#2 (LOC = C2): grantor = 226, grantee = 224, transfer = 225
- **Effective May 1, 2021**, some courts impose a Regional Congestion Relief Fee pursuant to [§ 58.1-802.4](#). The rate of this fee, when the consideration or value of the interest, whichever is greater, equals or exceeds \$100, is \$0.10 for each \$100 or fraction thereof. The fee is imposed on the grantor and is based on the date of recording in the clerk's office. Account code for this fee is 014. Instruments having an asterisk (\*) in the RCRF 014 column are eligible for the fee: DAOC, DB, DBL, DBS, DBSLE, DBST, DCOR, DDRT, DEX, DIT, DLF, DOA, DQC, DSC, DTAX, DTD, DTF, DVL.

- Recordings in a multiple jurisdiction court, like Prince William County/Manassas Park City/Manassas City use the below local recordation fees:
    - County (LOC = CO): grantor = 220, grantee = 213, transfer = 212
    - City #1 (LOC = CI): grantor = 223, grantee = 214, transfer = 222
    - City#2 (LOC = C2): grantor = 226, grantee = 224, transfer = 225
  - **Effective July 1, 2020**, some courts impose a Hampton Roads Transit Fund pursuant to § 58.1-802.5. The rate of this fee, when the consideration or value of interest, whichever is greater, equals or exceeds \$100, is \$0.06 for each \$100 or fraction thereof. The fee is imposed on the grantor and is based on the date of recording in the clerk's office. Account code for this fee is 022. Instruments having an asterisk (\*) in the HRTF 022 column are eligible for the fee: DAOC, DB, DBL, DBS, DBSLE, DBST, DCOR, DDRT, DEX, DIT, DLF, DOA, DQC, DSC, DTAX, DTD, DTF, DVL.
  - **Effective July 1, 2020**, pursuant to [HB306/SB938 § 17.1-275](#) the Virginia State Library fee (account code 145) for Recording and Indexing is increased from \$1.50 to \$3.50. The fee is imposed for the recording and indexing of certain documents, including plats or map sheets larger than 8 ½ x 14. This increase also applies to Wills and Fiduciary documents.
4. Exemption from Clerk's Fee [§ 17.1-266](#)
- The Commonwealth and localities are exempt from paying clerk's fee when presenting instruments for recordation. No clerk, sheriff or other officer shall receive payment out of the state treasury for any services rendered in cases of the Commonwealth, whether in a court of record or a court not of record, except as allowed by statute. Localities shall be exempt from paying fees for services rendered by a clerk or other court officer for cases, whether in a court of record or a court not of record, when the locality is a party to a case commenced in a court serving that locality or in any other jurisdiction when the localities have a reciprocal waiver of fees agreement, Sheriffs may, in writing, grant a waiver of sheriff's fee to one or more localities.

1. Exemption from Clerk's Fee [§ 17.1-266](#)

The Commonwealth and localities are exempt from paying clerk's fee when presenting instruments for recordation. No clerk, sheriff, or other officer shall receive payment out of the state treasury for any services rendered in cases of the Commonwealth, whether in a court of record or a court not of record, except as allowed by statute. Localities shall be exempt from paying fees for services rendered by a clerk or other court officer for cases, whether in a court of record or a court not of record, when the locality is a party to a case commenced in a court serving that locality or in any other jurisdiction when the localities have a reciprocal waiver of fees agreement, Sheriffs may, in writing, grant a waiver of sheriff's fee to one or more localities.

2. Additional Valid Account Codes:

When filing type code = 206, 501, 503, 509, 511, 515, 517, 518, 520, 521, 522, or 523 and F4 is pressed to format to the collect process service and depository items, the civil receipt displays only the account code, like 511, with a \$0.00 amount and the filing type code is changed to PET when COMM BY = INIT, JAOT when COMM BY = JAPL, and GAOT when COMM BY = GAPL.

3. Preset Account Codes on the **FAS Court Reference Record**

**219, 229, 228, 237, and 426** amounts preset by court request on the OES/SCV court financial reference record (FIN REF).

- a. As of July 1, 2009, [§ 17.1-281\(A\)](#), the **219 Law Library** fee cannot exceed \$4, the **229 Courthouse Maintenance** fee cannot exceed \$2, and the combined assessment for the 219 and 229 fees cannot exceed \$6.
- b. The **237 Background Check** fee is charged by some courts on Concealed Handgun Permits and cannot exceed \$35.
- c. The **228 Courthouse Construction** fee cannot exceed \$3, and applies only to those civil actions whose amount in controversy is greater than \$500.00.
- d. [§ 17.1-258.3](#) sets forth the **426 EFILE Fee** that can be used by E-Filing courts for copy fees, subscriber fees, and an additional maximum \$5 fee charge for every civil case initially filed by paper.

4. Special Calculation Notes

- a. [§ 17.1-275\(A\)\(27\)](#) requires a credit/debit card convenience fee (account code 407) **not to exceed** 4% of the amount paid or flat fee of \$2 per transaction, or the greater of \$2 or percentage (max 4%) of amount paid.
- b. Fees for process and service [§ 17.1-272\(A\)](#) for all filing type codes, except ATT and LEVY, is a \$12 sheriff fee (206) for each person, firm or corporation served when the body is not taken and making a return thereof. Fees for process and service [§ 17.1-272\(B\)](#) is a \$25 sheriff fee (206) for an ATT and LEVY.
- c. For **recovery of monetary damages**, these civil filing type codes require a suit amount: AL, ATT, CC, CJ, CNTR, COMP, CTAX, CTP, DECL, DET, EJCT, GAPL, GARN, GTOR, ITOR, LIEN, MED, MV, PROD, UD, VEND, WD.
- d. For **no monetary damage actions**, these civil filing type codes require a \$0.00 suit amount: CC, CTP, DECL, GAPL, and UD.
- e. Filing types that change after a fee calculation are:
  - Filing types changing to COND after calculation: CDC, CDE, CDL, DRAW, JUST, CERT
  - Filing types changing to PET after calculation: CCON, CON, DIST, and LEVY.
  - Filing types changing to GAOT after calculation: GANC.
- f. ROMC calculation may include an additional \$3.00 Bond fee under account code 315

5. Adult Civil Filing Types Notes

- Civil filing type codes that calculate a \$50 clerk fee (304) for all suit amounts: **COMP, MECH, VEND, LIEN.**
- **CJ** (Confessed Judgment) includes fees a 307 @ \$5 docketing fee and another 106 @ \$5 technology trust fund fee.
- **COM** (Complaint). Limit use for statistical reasons. Example, using COM instead of DIV for divorce will **not** give you credit for the divorce case on the Caseload Statistical Report.

**Note:** COM and PET are not available filing type codes on the circuit court civil cover sheet CC-1416 and the circuit web civil filing fee calculation.
- **CHP** (Concealed Handgun Permit) account code 237 amount preset by court request on the OES/SCV court financial reference record (FIN REF).

- **GARN** (Garnishment) includes a \$12 sheriff fee (206) for service on the garnishee **and** a \$12 sheriff fee (206) for service on the debtor.  
**Effective November 1, 2021:** When the garnishment includes a Writ of Fi Fa (FIFA = Y on civil receipt), a \$1.50 execution fee is added to the Civil Filing Fee (304). When the FIFA box is checked, **there will no longer be** four (4) sheriff fees assessed, **and** only two (2) sheriff fees will be assessed.
- **INTR** (Interrogatory Summons) includes a \$12 sheriff fee (206) for service on the judgment debtor. When the interrogatory includes a Writ of Fi Fa (FIFA = Y on civil receipt), a \$1.50 execution fee (304) is also charged.
- **COND** (Condemnation): See CDC, CDE, CDL, CERT, DRAW, and JUST filings by the Commonwealth, Locality, and Electric Authority/Sanitary District, etc. For VDOT filings with a plat, use CDC with \$5 @ code 304 clerk fee.
- **VEL** (Violation of an Election Law): Civil penalty against the respondent in the amount not exceeding \$50,000 for a first violation **and** in the amount not exceeding \$100,000 for any subsequent violation. Such civil penalties are payable in account code (152) Civil Penalty – Violation of an Election Law.

Costs, taxes and fees on appealed cases shall be assessed only in those cases in which a trial fee could have been assessed in the juvenile and domestic relations court and shall be collected in the circuit court, except that the appeal to circuit court of any case in which a fee either was or could have been assessed pursuant to [§ 16.1-69.48:5](#) shall also be in accordance with [§ 16.1-296.2](#).”

If petition is appealed and the defendant turns 18, our recommendation is no costs assessed on the petition (unless ordered by Judge).
2. **Deferred disposition of proceedings:** Assessment of costs when ordered by the court for a deferred disposition in drug cases, domestic violence cases and certain property offenses is authorized by Va. Code §§ [18.2-251](#), [18.2-57.3](#) and [19.2-303.2](#).
3. **Toll road violations:** Assessment of costs and penalty when ordered by the court for a violation of Va. Code §§ [46.2-819.1](#) and [46.2-819.3](#). DMV only suspends vehicle registration when there is a failure to pay fines/costs/penalties.



4. [§ 19.2-363](#). **Authority of Governor to grant relief from fines and penalties:** The Governor shall have power, in his discretion, to remit, in whole or in part, fines and penalties, in all cases of felony or misdemeanor, after conviction. The defendant's petition of relief is set forth in [§ 19.2-364](#).
5. Do not assess **district and JDR court costs for appeals** of a civil violation when the CMS FM = **O** or **C**. The circuit court would, unless specifically prohibited by statute, assess all applicable circuit court costs upon conviction.
6. **ANCM/Ancillary Misdemeanor:** Any Misdemeanor Offense certified pursuant to [§ 19.2-190.1](#), shall proceed in the same manner as a misdemeanor appeal to the Circuit court pursuant to [§ 16.1-136](#). **Only Court Appointed Attorney fees apply.**

9. **Photo Speed Monitoring Devices:** Civil Penalty of not more than \$100 (costs will be assessed) and is collected in account code 201 if summons issued by locality or account code 110 "Literary Fund", if summons issued by Virginia State Police §§ [46.2-208](#), [46.2-882](#) and 46.2-882.1.

- (B) Any person who possesses on his person or in any public place marijuana or marijuana products in excess of the amount set forth in subsection A is subject to a civil penalty of no more than \$25 except as otherwise provided in this section. The penalty for any violations of this section by an adult shall be prepayable according to the procedures in § 16.1-69.40:2.
- (C) With the exception of possession by a person in his residence or possession by a licensee in the course of his duties related to such licensee's marijuana establishment, any person who possesses on his person or in any public place (i) more than four ounces but not more than one pound of marijuana or an equivalent amount of marijuana product as determined by regulation promulgated by the Board is guilty of a Class 3 misdemeanor and, for a second or subsequent offense, a Class 2 misdemeanor and (ii) more than one pound of marijuana or an equivalent amount of marijuana product as determined by regulation promulgated by the Board is guilty of a felony punishable by a term of imprisonment of not less than one year nor more than 10 years and a fine of not more than \$250,000 or both. Fine is assessed in account code **107 Drug Offender Assessment Fund (DOAF)**.
16. **Safety Lap Belts and Shoulder Harnesses:** [§ 46.2-1094](#) – Any driver and any other person at least 18 years of age and occupying the front seat of a motor vehicle shall wear the appropriate safety belt system at all times. Any person who violates this section is subject to a Civil Penalty of \$25 to be paid into the state treasury, account code **110**.
