



Docketing of Criminal and Traffic Cases in the District Courts –

Cases are to be assigned as follows:

Richmond Police Department –

Offenses occurring in 1st and 2nd Precincts, as well as all cases initiated by Officers assigned to the SOD Traffic Division (regardless of precinct), shall be docketed in the Marsh Criminal/Traffic Division at Manchester. Criminal Arraignments should be made returnable at 9:00 a.m. Traffic Arraignments should be made returnable at 11:30 a.m.

Offenses occurring in 3rd and 4th Precincts shall be docketed in the John Marshall Criminal/Traffic Division. Criminal Arraignments should be made returnable at 9:00 a.m. Traffic Arraignments should be made returnable at 11:30 a.m.

Other Law Enforcement Agencies –

The Following Law Enforcement Agencies bringing charges shall set all of their cases in the John Marshall Criminal/Traffic Division. Criminal Cases should be set at 9:00 a.m. Traffic Cases should be set at 11:30 a.m. Animal Control Cases should be set at 11:00 a.m. on Thursdays.
