4. Preparation Details
 - a. This form is intended for use with the form DC-582, REQUEST FOR VIRGINIA REGISTRATION OF A CHILD CUSTODY AND/OR VISITATION DETERMINATION FROM ANOTHER STATE, to implement the registration provisions of the Uniform Child Custody Jurisdiction and Support Act (UCCJEA), Virginia Code §§ 20-146.1 through 20-146.38.
 - b. Upon receipt of a completed form DC-582, REQUEST FOR VIRGINIA REGISTRATION OF A CHILD CUSTODY AND/OR VISITATION DETERMINATION FROM ANOTHER STATE, the clerk should prepare form DC-583. Copies of the completed forms DC-582, DC-583, the foreign custody and/or visitation determination pertaining to the request and any other documents and relevant information accompanying the determination should be served on the non-registering party. Do not include the DC-582 if non-disclosure is requested.
 - c. The non-registering party may request a hearing to contest the registration at any time, Virginia Code § 20-146.26.
