

# Accessing Case Filings and Dispositions Data for the District and Circuit Courts of Virginia on the Judicial System's Website

Quick Reference Guide

Case filings and dispositions data are available for the district courts and circuit courts of Virginia on the Virginia Judicial System's website.

Follow the steps 1-5 below to access the data OR Click here and then follow steps 4 and 5.

- 1. Go to <a href="https://vacourts.gov">https://vacourts.gov</a>. Locate the Search field in the upper right corner.
- 2. Click to place your cursor in the space provided. Do not click the magnifying glass icon.
- 3. Select Caseload Statistical Information (CSI) from the list of options displayed. This will route you to the Court Performance & Statistical Services Division home page.
- 4. Under Caseload Statistical Information (CSI), select the level of court (General District Court, Juvenile and Domestic Relations District Court or Circuit Court) for which you want to view data.
- 5. If the reports do not automatically display, select the down arrow on the right of the Filings or Dispositions headers to expand the section. Selecting this arrow in the up position will hide the section.



Power BI reports <u>refresh daily</u>. To view the static number of cases filed and disposed during each month of the prior and current calendar year, download the monthly PDF report.

**Report Pages:** Filings and Dispositions Reports provide data on three levels (locale, district or circuit, and state) and by Years and Months. The data reported on each page is described on the Public Help page, which is at the beginning of each report. Reports open to the Public Help page by default.

## To print case filings and dispositions reports using the Power BI web reports, you will need to use the print option in your web browser.

When printing, note that <u>only the data shown on the screen will print</u>. This means that visuals with a scroll bar, like the one highlighted below, will not print the divisions and case types that are below Show Cause-SC.
